- 4) copy of the First Aid certificate (BLS-D, WFR, or similar); to be valid according the Italian Rules, the retraining of the First Aid certification has to be done every 2 years;
- 5) medical certificate of competence for not-competitive sport, issued in Italy, valid (one year);
- 6) copy of the **Codice Fiscale** ("Fiscal code"), issued by the "Agenzia delle Entrate", in Italy or by the Consulate or the Consular Registry. This last document have to be sent to the Federal Secretariat within 8 days from the conversation exam/course. In case of no-sbmission of this document, the membership to FIRAft will be cancelled and the qualification will be not recognised.

Only if in the respective Country doesn't exist a WRF Member, the above mentioned documents 1) and 2) can be replaced with the **Curriculum vitae** (rafting experience only) and the Rafting certifications. IRF certifications are not recognised in Italy.
